TO THE VOTERS OF WAUPACA COUNTY:

Notice is hereby given of a general election to be held in Waupaca County, on November 3, 2020, at which the officers named below shall be chosen. The names of the candidates for each office to be voted for, whose nominations have been certified to or filed in this office, are given under the title of the office and under the appropriate party or other designation, each in its proper column, together with the questions submitted to a vote, in the sample ballot below.

Information to Voters

Upon entering the polling place, a voter shall state his or her name and address, show an acceptable form of photo identification and sign the poll book before being permitted to vote. **If a voter does not have acceptable photo identification, the voter may obtain a free photo ID for voting from the Division of Motor Vehicles.** If a voter is not registered to vote, a voter may register to vote at the polling place serving his or her residence if the voter provides proof of residence. Where ballots are distributed to voters, the initials of two inspectors must appear on the ballot. Upon being permitted to vote, the voter shall retire alone to a voting booth or machine and cast his or her ballot except that a voter who is a parent or guardian may be accompanied by the voter's minor child or minor ward. An election official may inform the voter of the proper manner for casting a vote, but the official may not in any manner advise or indicate a particular voting choice.

Voting for President and Vice President

A vote for candidates for President and Vice President is a vote for the presidential electors of those candidates. A write-in vote for President and Vice President must designate the name of a presidential candidate. A write-in vote for a candidate for President only will be counted. A write-in vote for a candidate for Vice President only will not be counted.

Where Paper Ballots are Used

The voter shall make an **(X)** or other mark in the square next to the name of the candidate of his or her choice for each office for which he or she intends to vote. To vote for a person whose name does not appear on the ballot, the voter shall write in the name of the person of his or her choice in the space provided for a write-in vote. When voting for President and Vice President, the voter shall make an **(X)** or other mark next to the set of candidates (ticket) for president and vice president for whom he or she intends to vote. To vote for a Presidential ticket that does not appear on the ballot, the voter shall write in the names of persons of his or her choice in the spaces provided. On referendum questions, the voter shall make a cross **(X)** in the square next to "yes" if in favor of the question, or the voter shall make a cross **(X)** in the square next to "no" if opposed to the question.

Where Optical Scan Voting is Used

The voter shall fill in the oval or connect the arrow next to the name of the candidate of his or her choice for each office for which he or she intends to vote. To vote for a person whose name does not appear on the ballot, the voter shall write in the name of the person of his or her choice in the space provided for a write-in vote and fill in the oval or connect the arrow next to the write-in line. When voting for President and Vice President, the voter shall fill in the oval or connect the arrow next to the set of candidates (ticket) for president and vice president for whom he or she intends to vote. To vote for a Presidential ticket that does not appear on the ballot, the voter shall write in the names of persons of his or her choice in the spaces provided and fill in the oval or connect the arrow next the write-in lines. On referendum questions, the voter shall fill in the oval or connect the arrow next to "yes" if in favor of the question, or the voter shall fill in the oval or connect the arrow next to "no" if opposed to the question.

Where Touch Screen Voting is Used

The voter shall touch the screen at the name of the candidate of his or her choice for each office for which he or she intends to vote. To vote for a person whose name does not appear on the ballot, the voter shall type in the name of the person of his or her choice in the space provided for a write-in vote. When voting for President and Vice President, the voter shall touch the screen at the set of candidates (ticket) for president and vice president for whom he or she intends to vote. To vote for a Presidential ticket that does not appear on the ballot, the voter shall type in the names of persons of his or her choice in the spaces provided. On referendum questions, the voter shall touch the screen at "yes" if in favor of the question or the voter shall touch the screen next to "no" if opposed to the question.

The vote should not be cast in any other manner. Not more than five minutes' time shall be allowed inside a voting booth. Sample ballots or other materials to assist the voter in marking his or her ballot may be taken into the booth and copied. The sample ballot shall not be shown to anyone so as to reveal how the ballot is marked.

Spoiled Ballots

If a voter spoils a **paper or optical scan** ballot, he or she shall return it to an election official who shall issue another ballot in its place, but not more than three ballots shall be issued to any one voter. If the ballot has not been initialed by two inspectors or is defective in any other way, the voter shall return it to the election official who shall issue a proper ballot in its place.

The voter may spoil a **touch screen** ballot at the voting station before the ballot is cast.

After Voting the Ballot

After an official **paper** ballot is marked, it shall be folded so that the inside marks do not show, but so the printed endorsements and inspectors' initials on the outside do show. The voter shall then deposit his or her folded ballot in the proper ballot box or deliver the ballot to an inspector for deposit and leave the polling place promptly.

After an official **optical scan** ballot is marked, it shall be inserted in the security sleeve so the marks do not show. The voter shall then insert the ballot in the voting device and discard the sleeve, or deliver the ballot to an inspector for deposit. The voter shall leave the polling place promptly.

After an official **touch screen** ballot is cast, the voter shall leave the polling place promptly.

A voter may select an individual to assist in casting his or her vote if the voter declares to the presiding official that he or she is unable to read, has difficulty reading, writing, or understanding English, or that due to disability is unable to cast his or her ballot. The selected individual rendering assistance may not be the voter's employer or an agent of that employer or an officer or agent of a labor organization which represents voter.

NOTICE OF REFERENDUM ELECTION CLINTONVILLE PUBLIC SCHOOL DISTRICT

TAKE NOTICE that a referendum election shall be held on November 3, 2020 in the Clintonville Public School District for the purpose of approving or rejecting an Initial Resolution adopted by the School Board of said District on August 10, 2020.

The Initial Resolution reads as follows:

INITIAL RESOLUTION AUTHORIZING
GENERAL OBLIGATION BONDS
IN AN AMOUNT NOT TO EXCEED \$37,000,000

BE IT RESOLVED by the School Board of the Clintonville Public School District, Waupaca, Shawano and Outagamie Counties, Wisconsin, that there shall be issued, pursuant to Chapter 67, Wisconsin Statutes, General Obligation Bonds in an amount not to exceed \$37,000,000 for the purpose of paying the costs of district-wide improvements to all school buildings and grounds including renovations to the existing middle school for purposes of creating a 4k-5th grade elementary school, addition of middle school and agri-science space to the existing high school, safety and traffic flow improvements, replacements and upgrades to building systems and infrastructure; and acquisition of related furnishings, fixtures and equipment.

The referendum ballot will ask District electors: "Shall the foregoing resolution of the School Board of the Clintonville Public School District be approved?"

A "yes" vote is in favor of the Initial Resolution set forth above and is a vote to approve the borrowing of not to exceed \$37,000,000 by the Clintonville Public School District through the issuance of General Obligation Bonds for the purpose of paying the costs of district-wide improvements to all school buildings and grounds including renovations to the existing middle school for purposes of creating a 4k-5th grade elementary school, addition of middle school and agri-science space to the existing high school, safety and traffic flow improvements, replacements and upgrades to building systems and infrastructure; and acquisition of related furnishings, fixtures and equipment.

A "no" vote is opposed to the Initial Resolution and is a vote to deny the Clintonville Public School District the authority to borrow not to exceed \$37,000,000 through the issuance of General Obligation Bonds for the purpose of paying the costs of district-wide improvements to all school buildings and grounds including renovations to the existing middle school for purposes of creating a 4k-5th grade elementary school, addition of middle school and agri-science space to the existing high school, safety and traffic flow improvements, replacements and upgrades to building systems and infrastructure; and acquisition of related furnishings, fixtures and equipment.

NOTICE OF REFERENDUM SCHOOL DISTRICT OF IOLA-SCANDINAVIA NOVEMBER 3, 2020

NOTICE IS HEREBY GIVEN, that at an election to be held in the School District of Iola-Scandinavia on November 3, 2020, the following proposed Revenue Limit Resolution of the School Board will be submitted to a vote of the people:

RESOLUTION AUTHORIZING THE SCHOOL
DISTRICT BUDGET TO EXCEED REVENUE
LIMIT FOR FIVE YEARS FOR
NON-RECURRING PURPOSES

BE IT RESOLVED by the School Board of the School District of Iola-Scandinavia, Waupaca and Portage Counties, Wisconsin that the revenues included in the School District budget be authorized to exceed the revenue limit specified in Section 121.91, Wisconsin Statutes, by \$1,250,000 per year for the 2021-2022 school year and the 2022-2023 school year, by \$1,400,000 per year for the 2023-2024 school year and the 2024-2025 school year and by \$1,500,000 for the 2025-2026 school year, for non-recurring purposes consisting of sustaining educational programming, student opportunities and operations.

The question will appear on the ballot as follows:

"Shall the School District of Iola-Scandinavia, Waupaca and Portage Counties, Wisconsin be authorized to exceed the revenue limit specified in Section 121.91, Wisconsin Statutes, by \$1,250,000 per year for the 2021-2022 school year and the 2022-2023 school year, by \$1,400,000 per year for the 2023-2024 school year and the 2024-2025 school year and by \$1,500,000 for the 2025-2026 school year, for non-recurring purposes consisting of sustaining educational programming, student opportunities and operations?"

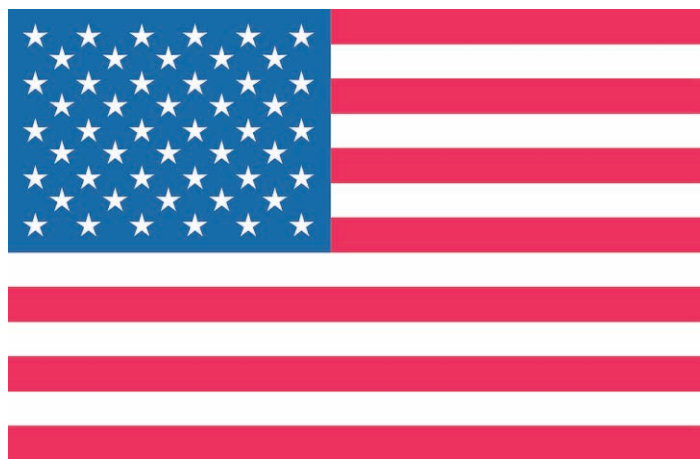
EXPLANATORY STATEMENT AND EFFECT OF VOTE

The referendum election ballot will ask District electors to vote "yes" or "no" on the referendum election question as set forth above.

A "yes" vote on the question is a vote to authorize the School District of Iola-Scandinavia budget to exceed the revenue limit specified in Section 121.91, Wisconsin Statutes, by \$1,250,000 per year for the 2021-2022 school year and the 2022-2023 school year, by \$1,400,000 per year for the 2023-2024 school year and the 2024-2025 school year and by \$1,500,000 for the 2025-2026 school year, for non-recurring purposes consisting of sustaining educational programming, student opportunities and operations.

A "no" vote on the question is a vote to deny the School District of Iola-Scandinavia the authority to exceed the revenue limit specified in Section 121.91, Wisconsin Statutes, by \$1,250,000 per year for the 2021-2022 school year and the 2022-2023 school year, by \$1,400,000 per year for the 2023-2024 school year and the 2024-2025 school year and by \$1,500,000 for the 2025-2026 school year, for non-recurring purposes consisting of sustaining educational programming, student opportunities and operations.

In the event a majority of the electors voting on the question vote "yes", the District will be authorized to exceed the revenue limit specified in Section 121.91, Wisconsin Statutes, by \$1,250,000 per year for the 2021-2022 school year and the 2022-2023 school year, by \$1,400,000 per year for the 2023-2024 school year and the 2024-2025 school year and by \$1,500,000 for the 2025-2026 school year, for non-recurring purposes consisting of sustaining educational programming, student opportunities and operations; if a majority vote "no" on the question set forth above, the District will not be so authorized.
