NOTICE OF SPECIAL TOWN MEETING OF THE ELECTORS

Notice is hereby given that on Tuesday, November 11, 2025, immediately following completion of the Public Hearing on the proposed 2026 Budget, a SPECIAL TOWN MEETING OF THE ELECTORS will be called pursuant to Section 60.12(1)(c) of Wisconsin Statutes by the Town Board, for the following purpose:

1. To consider the adoption of a resolution by the electors at the town meeting endorsing a town board resolution which proposes that the town levy exceed the state allowable levy limit under Wis. Stat. § 66.0602, specifically a proposed tax levy which would exceed the allowable town tax levy for 2025, after adjustments, by 79.237 %, for a dollar increase of \$100,000.00.
2. To approve the 2025 town tax levy to be paid in 2026 pursuant to Section 60.10(1)(a) of Wisconsin Statutes.
