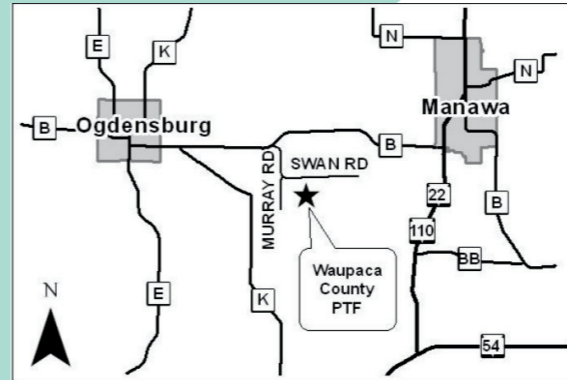
PROGRAM RATE

SOLID WASTE

\$95.00 per ton
\$20.00 min. charge (up to 400lbs.)

Mattresses & Box Springs- \$15 ea.

Trash, furniture, toilets, deer carcasses, shingles, C&D, etc.

NO asbestos-containing material accepted at Facility.

BRUSH - TREES

\$20.00 per ton NO stumps
\$5.00 min. charge (up to 500lbs.)

LEAVES - GRASS - PINE NEEDLES

No charge

APPLIANCES

***Freon Units- \$15 ea.**

Refrigerator, freezer, dehumidifier, air conditioner, etc.

***Non-Freon Units- \$10 ea.**

Stove, microwave, oven, washer, dryer, water heaters, etc.

LATEX PAINT HARDENER

Per Bag \$4.00 ea.

RECYCLABLES

No charge - 4 sorts required



1) GLASS

Food & beverage only
NO window glass, light bulbs, mirrors, dishware, ceramics



2) PLASTIC JUGS, TUBS, BOTTLES, CONTAINERS

Food, beverage, household Dairy, produce, bakery, deli
NO black plastic, bags, 5 gal. pails, motor oil bottles, laundry baskets



3) METAL BOTTLES & CANS

Aluminum, steel, tin, bi-metal cans
Completely empty aerosol cans



4) PAPER PRODUCTS

Newspaper, magazines, mixed paper, cardboard, & boxboard.
NO food-contaminated paper, tissue paper, wrapping paper, wax-coated cardboard
